Most people who are infected with Covid-19 will experience mild symptoms, such as a cough and a fever, and will recover without the need for specialist treatment. Evidence suggests that children and adolescents are less likely to develop severe symptoms of the disease but can still transmit the disease to others.

The aim of this risk assessment is to reduce the risk of spreading Covid-19 as far as possible, by identifying and implementing measures that will help to keep staff, children and their families safe from infection.

This risk assessment applies to HUB Sports extra-curricular activities, holiday camps and Physical Education & School Sport Service.

A risk assessment is put in place to analyse potential hazards, the risk of someone being harmed and control measures put in place to create a safer environment for all.
